Background:

The interventions include: 1) Support Human Resources for health skills development for HIV/TB service delivery through the Extension for community healthcare outcomes (project ECHO) platform 2) providing above-site Health Information System (HIS) technical support and coordination for sustainable overall health and HIV/TB program implementation; strengthening National HIV/TB and overall, Health Program monitoring & evaluation at the national, state and county levels; and 4) planning and coordination of differentiated service delivery models with a focus on community HIV prevention activities to promote use of community services.

Position summary

The State HIV/TB Officer will provide technical and programmatic support to the State health department to achieve set program objectives, including delivery of quality HIV prevention, care, and support services in supported facilities and communities. H/She will work closely with the county HIV/TB officers to plan, organize and manage tasks to integrate and improve the quality of services and implement strategies to achieve program targets. In addition, the State HIV/TB officer interphases with stakeholders on behalf of the AFENET country office to strengthen the health system at the state level.

Specific Responsibilities:

Support the state ministry of health HIV/TB/STI departments and county HIV/TB departments to develop periodic program work plans, and budgets

Provide technical and programmatic support to the state health department and county HIV/TB officers to implement HIV/TB program strategies and activities to achieve set deliverables in line with national standards/protocols and global best practice

Liaise with the county HIV/TB officer to plan and coordinate periodic joint supportive supervisory visits to implementing facilities and civil society organizations in the community

Work closely with the state and central office program team, including monitoring and evaluation strategic information advisors, to monitor, analyze and use data to identify areas of need, inform performance improvement strategies and allocate resources to improve program performance along

Coordinate and support quarterly data and program review meetings with the state health

Identify training needs of staff involved in HIV/TB care and treatment, plan and coordinate capacity-building efforts for health care workers involved with program implementation at

Work closely with the state health department, stakeholders, the county HIV/TB officers, and representatives of service beneficiaries to strengthen mechanisms for delivery of integrated TB, HIV, and sexual and reproductive health services in the state
